

NOMINATING COMMITTEE RULES

(Extract from WFRW Bylaws – As Amended April 17, 2021 (Page 10-11))

ARTICLE VIII

COMMITTEES

SECTION 2. SPECIAL COMMITTEES

C. NOMINATING COMMITTEE

1. A nominating committee of seven members and two alternates shall be elected by majority vote by the WFRW Board of Directors no later than four months prior to the WFRW Biennial Convention at which elections are to take place. When there are more than three candidates for the alternate positions, the vote shall be by plurality. Nominees must be present to accept nominations to the nominating committee or must have given consent to serve if elected. Five shall be members of the WFRW Board of Directors, and two shall be at-large members. No club shall have more than one member on the committee at the same time. No nominating committee member shall serve two consecutive terms.
2. The chair of the nominating committee shall be elected by the committee.
3. The nominating committee shall submit one nominee for each office in a written report to the WFRW President to include with the Official Call to the WFRW Biennial Convention at which elections are to take place.
4. Nominations may be made from the floor of the WFRW Biennial Convention following the report of the nominating committee. No one shall be nominated who has not given consent to serve if elected.
